# SHOW RULES & REGULATIONS

1. Sponsor agrees to furnish a draped booth, with electricity. Table and chair rentals are available through Downeast Show Promotions.
2. An Exhibitor may only display products or services sold by him in his regular course of business. Only products or services pertinent to or closely related to the theme of the Show will be permitted.
3. All materials used in booths for decoration shall be of the approved, flame-proof type. Exhibitors wishing to use helium or other flammable material must be in compliance with local fire codes and city ordinances.
4. Sponsor will retain the right to change the show dates specified, should factors beyond Sponsor's control necessitate such change.
5. Exhibitors and their agents shall at all times treat the guests and customers with courtesy and respect. A hard sell approach is not permitted. All exhibits and products to be sold and other items in connection therewith shall be in good taste and of high quality and shall be provided for and maintained in an acceptable manner.
6. All exhibits must be in order with all packing cartons and trash removed one hour prior to opening of the show.
7. All exhibits will not be permitted to protrude into adjoining booths or the aisles.
8. Sponsor will not be responsible for nor will it guarantee the Exhibitor against loss of any kind, including weather damage or acts of God.
9. Sponsor reserves the right to alter or relocate booth position.
10. Exhibitors agree to indemnify and hold harmless sponsor from and against any and all liability, claims, demands, expenses, fees, fines, penalties, suits, proceedings, actions and causes of action of any kind and nature arising or growing out of or in any way connected with Exhibitor's activities on the property of the show.
11. Exhibitor agrees to keep and leave their exhibit space in a clean and orderly fashion and to provide all required janitorial services within the vicinity of their exhibit space. Exhibitor is financially responsible for any damage to the premises or equipment therein by exhibitor, his agents or employees.
12. Exhibitor agrees to abide by all federal, state, city, and Show regulations. All rules and regulations added by sponsor through written notice will be adhered to. In the event of a conflict between the rules and regulations herein, Show rules and regulations shall take precedence. Sponsor reserves the right to discontinue any exhibit in violation of such rules and regulations and to terminate this contract, with or without cause at any time during the term hereof. No refund of booth space will be made to any Exhibitor who is asked to leave the show because of illegal operations or violation of rules and regulations, nor shall sponsor be liable for any expenditures attendant to such termination. Sponsor will be not obliged to refund any part of the Exhibit Fee should Exhibitor cancel for any reason after signing Exhibitor contract.
13. It is understood and agreed that Exhibitor and any person connected with your company or organization with which this Agreement is made will abide by any and all rules and regulations concerning its activity in the Show.
14. Vendors are not permitted to share booth space with another vendor unless prior written approval is received from Downeast Show Promotions.
